### HON. ROBERT SMITH TO TEACH NOVEMBER 2016 CLE

Hon. Robert Smith, formerly of the New York Court of Appeals, will teach the **November 15**, **2016** CLE titled "*The Art of Persuasion*" at the New Rochelle Public Library. Judge Smith was nominated by Governor Pataki to the Court of Appeals in November 2003 and served for eleven years, beginning January 12, 2004. He authored 300 opinions while he was on the Court, of which approximately 200 were majority decisions. Following his retirement from the Court of Appeals, Judge Smith returned to private practice and joined the law firm of Friedman Kaplan Seiler & Adelman LLP, where he leads the firm's appellate practice.



#### NRBA SOFTBALL TEAM UPDATE By Jeffrey Levin, Esq.



Team manager Rich Grayson for his post season synopsis reported that the New Rochelle Bar

Association softball team had a strong finish to the 2016 season. The team won its last three games to finish with a record of 6-6. The NRBA Purple Barristers lost a season ending consolation playoff game, but the team's 2016 performance was its best record in three years. The team ended the 2015 season 4-8, and then lost its sole playoff game.

Under the leadership of Grayson, the NRBA has fielded a softball team in the New Rochelle Industrial and Open Divisions since 1985. After many seasons of frustration, the team in 2012 with a regular season record of 7-5 then won its two playoff games to win its first tournament championship to become the champions of the New Rochelle Softball League's Open (American Division).

A highlight of the 2016 campaign was produced by NRBA member, Jay Goldstein. After playing softball for 21 seasons, at the age of nearly 65, Goldstein hit his first home run for the NRBA team. Goldstein reported that, "I knew it was good for a triple once I hit it to right field, but when the 3<sup>rd</sup> base coach waved me home I had a few choice words for him. I saw the throw coming in to the plate and a slide would have been a good idea, but I ducked low under the tag and hit the plate with my left hand just ahead of the tag." An inside-the-park home run at any age is an impressive feat.

NRBA members wearing the team's purple and white colors this summer, in addition to Grayson and Goldstein, were Mitch Schwartz with a .643 batting average, Michael Meccia, Alex Fear, and Ken Yudell.

The franchise's total record for its 32 seasons in the Industrial and Open Divisions is 181-225 and 5-10 in playoffs with the tournament championship. Manager Grayson has assured the NRBA that our team will be back for its 33<sup>rd</sup> season in 2017.

#### NYC AMNESTY PROGRAM FOR ENVIRONMENTAL CONTROL BOARD JUDGMENTS

New York City is offering individuals businesses a one-time opportunity to reduce **Board** violation their Environmental Control judgments if settled via a special online portal by December 12, 2016. As the City's official website for the "Forgiving Fines, the NYC Amnesty Program" (the "Program") website states: "If you have unresolved Environmental Control Board (ECB) violations in judgment, you may be eligible Forgiving Fines. the **NYC** Amnesty Program. During the amnesty program, the City will waive penalties and interest charges on ECB violations that went into judgment before June 12, 2016. Some of these violations may also be eligible to have their base penalty reduced. The amnesty program will be available from September 12, 2016, through December 12, 2016." Any business or individual who is named on a violation judgment that has been adjudicated by the ECB may take advantage of the Program, which is run by the New York City Department of Finance.

The Program is, "a three-month program authorized by Mayor de Blasio and the City Council that allows participants to resolve violations they received from New York City's Department of Buildings, Transportation, Sanitation, Fire Department, Landmarks, Parks or other City of New York (City) agencies and which are now in judgment," from the ECB. As the fine print on the flyer produced jointly by the NYC Office of Mayor Bill DiBlasio and NYC Department of Finance the **ECB** violations states, must judgment. "This means the City has taken the legal step of filing a public record of your liability in

court for the entire amount due. After the court filing, interest accrues."

Starting on September 12, 2016, individuals and businesses will be able to search for and pay for violations in judgment by visiting the Amnesty City Pav application on the Amnesty Page (nyc.gov/forgivingfines). If a person or business is unable to find all of their outstanding judgment violations using a single search, they may continue to search and pay for violations throughout the three-month program. DOF will send a list of additional violations if the user does not pay for all of the violations listed in the search. An individual or business must resolve and admit liability for all the debt owed in order to receive amnesty.

Once applicable violations are identified, the Program provides automatic discounts and repayment terms under alternatescenarios.

The amount of the discount depends upon whether the violator attended a hearing or not. For judgments where the violator did not attend a hearing, the amnesty amount due will be the base penalty without the typical additional penalties for failing to attend the hearing (known as "default penalties") nor interest. If the violator did attend a hearing, then the judgment can be settled by paying only 75% of the base penalty amount, also without interest (a discount of 25% off the original base penalty amount).

The repayment terms depend upon whether the ameliorative violation also requires action. Schedule A violations are those violations t require payment while Schedule hat only "compliance violations (or violations") are those violations that require both payment and corrective action. For Schedule A violations, the violator must pay the entire amount due by December 12, 2016. For Schedule B violations, the violator must pay at least 25% of the amnesty amount due by the end of the program on December 12, 2016. The Schedule B violator with then have months from the initial six payment

to both correct the violation and to pay the remaining balance. Alternatively, the violator may choose to pay the entire resolution amount before the end of the Program but still enjoy the full six months to correct the condition which gave rise to the violation.

The Program excludes (i) parking tickets (ii) criminal violations (iii) violations which are over \$25,000; (iv) violations that are part of an installment agreement or other resolution agreement for the payment of ECB judgments with the Department of Finance, a City Marshal, the Sheriff or Law Department or an outside collection agency; by a business or and (v) violations included individual in the 2009 Penalty Relief exclusions Program. Other limitations. and eligibility requirements also apply.

Below are some of the most common violations which are covered by the Program:

- Illegal Posting of Handbill or Notice
- Snow, Ice or Dirt on Sidewalk
- Improper Storage of Receptacles
- Improper or Misused Recycling Containers
- Improper Disposal of Trash or Recyclables
- Failure to Comply With an Order of the Commissioner
- Failure to Properly place Recyclables for Collection
- Work without a Permit
- Failure to Conduct Required Inspections and Tests
- Failure to submit Affidavits, Design/Installation or Other Documents
- Vending Merchandise or Food in a Restricted Area


## INSTALLATION OF THE NEW NRBA OFFICERS AND DIRECTORS
