

Governor Hochul Proposes "Equity-Based" FY2023 Budget that will Impact the Legal Profession

On January 18, 2022, Governor Kathy Hochul, assuming office after a 10 year reign by Governor Andrew Cuomo, presented her first state budget to the legislature. The governor's initial budget

proposal is significant because New York's strong executive budget system, adopted by voters in 1927, is unbalanced by design. What the governor therefore proposes in her budget is important because it often sets the tone for the various policy initiatives the legislature will consider before the budget is passed by its statutory deadline of March 30, and often for the duration of the legislative session as well (which is scheduled to adjourn this year on June 2). In this year's proposed FY2023 Executive Budget, there are many proposals impacting the legal profession, and they can be summed up in one word: equity.

While it is beyond the scope of this article to discuss the differences between equality and equity as a desirable social goal, New York's proposed FY 2023 executive budget falls squarely on the side of equity, and this will create both opportunities and responsibilities for lawyers practicing in New York.

In addition to funding the judiciary and court system, the executive budget, through various "Article VII" bills, also contains many substantive policy recommendations and draft statutory proposals that often, quite frankly, are not directly related to any appropriations, but are nonetheless linked to the appropriations portions of the budget for purposes of political leverage (and that leverage is most decidedly tilted in favor of the executive).

In her proposed FY 2023 budget (again, it is a proposed budget because it must be negotiated and adopted by the legislature), the governor seeks to 'advance New York's place as a national equity model." To do this, she is proposing policy changes in many areas of existing law, as well as entirely new programs and initiatives.

To advance her "national equity model" Governor Hochul has proposed the following as part of her 2023 budget initiative:

- Create a state Council on Gender Equality;
- Pass an Equal Rights Amendment;
- Bolster the state's anti-discrimination laws;

- Promote equity and economic justice in the cannabis industry;
- Build on New York's support for Minority and Women-Owned (MWBE) businesses;
- Adopt additional protections to protect New York's LGBTQIA community;
- Strengthen immigrant services; and
- Boost local veterans programs.

These proposals (and many more) will be included directly in the budget either through current appropriations and Article VII bills, amendments to those bills (which will be released on February 8 and 17), or by individual bills introduced and considered outside of the budget process.

All of these initiatives will create opportunities for attorneys representing clients who may be the beneficiaries of these new programs and laws. As the state budget process unfolds over the next two months, the New Rochelle Bar Association will continue to monitor and report to its membership on how these proposals, once enacted into law, may present such new practice opportunities for the bar.


